Rules and regulations:

1. Applicant's personal background must be free of any pending or past legal activity that demeans the image and dignity of the Chickasaw Princess.
2. Applicant must reside in the Chickasaw Nation treaty territory.
3. Applicant must be 17-25 years of age as of September 29, 2025.
4. Applicants, contestants and the Chickasaw Princess must be single, never married, never cohabitating and not have children.
5. Applicant must be at least one-quarter Chickasaw and registered as a citizen of the Chickasaw Nation. Applicant and/or their parent/legal guardian must be registered voters of the Chickasaw Nation.
6. Applicant must be a natural-born female and continue to present as such.
7. Applicant cannot have previously served as the Chickasaw Princess.
8. Traditional dress requirements will be the responsibility of each contestant, but applicant must not commence preparations unless and until their application is accepted and they receive notification from the Chickasaw Princess Program manager. The traditional dress will include a cotton dress and an apron.
9. The Chickasaw Princess must be attending school or college and working toward a diploma while maintaining at least a 2.0 grade point average and be in good standing with the school/or be a high school graduate or equivalent. If a postsecondary applicant is not pursuing higher education or specialized training, they must be employed full-time or part-time. The employment schedule must be somewhat flexible to accommodate participating in Chickasaw Nation-related and other events.
10. The Chickasaw Princess must have reliable transportation.
11. The Chickasaw Princess will represent the Chickasaw Nation in a positive manner at various Chickasaw Nation-related and other events throughout the year.
12. The Chickasaw Princess will abstain from illegal drugs, alcohol and tobacco-related products during their reign as Chickasaw Princess.
13. If for any reason the Chickasaw Princess is requested or elects not to participate, their title, crown, sash and shawl will be returned to the Chickasaw Nation. Their successor will be determined based on the pageant contest results. The successor will complete the remainder of the Chickasaw Princess reign but will only be entitled to any awards and gifts received after the successor's reign begins.
