72-Hour Photography Competition Rules and Guidelines

Each photographer must submit a non-refundable entry fee of \$30 before the start of the 72-hour photography competition (Friday, September 6 - Monday, September 9, 2024).

Eligibility:

- 1. The 72-hour photography competition is open to all photographers.
- 2. The competition will have three categories: youth, amateur and professional.
- 3. *Any photographer who is under 18 years of age and who has not graduated high school is considered a youth for category eligibility.
- 4. **Any photographer who derives more than \$15,000 of income annually or more than 30% of income annually from photography is considered a professional for category eligibility.
- 5. Contest personnel reserves the right to reject photographers, or reassign them to a category, based on information that may come to light during the competition or judging process.
- 6. No age limits are imposed upon photographers, but all photographers must submit photos of their own creation.
- 7. Parents and legal guardians of underage photographers must refrain from active guidance and assistance with concepts and technical considerations.

Time frame and themes:

- 1. All photographs must be shot and submitted within the 72-hour contest window.
- 2. The theme for the 72-hour photography competition will be emailed to photographers no later than 5:00 p.m. CST on Friday, September 6, 2024.
- 3. Upon receiving the theme, each photographer will be given approximately 72 hours to complete the competition.
- 4. The 72 hours cannot be restarted, suspended or otherwise altered by contest personnel.
- 5. Each photographer is responsible for ensuring the date and time on their camera are set correctly before the beginning of the competition.
- 6. Themes will not be made available to the photographer before the start of the competition.

Submission technical specifications:

- 1. Photograph files must be submitted by email to ArtistInfo@Chickasaw.net or on a compact disc (CD) or a thumb drive no later than Monday, September 9, 2024, by 5:00 p.m. CST.
- 2. Photograph files can be submitted in person on a CD or a thumb drive to 201 North Broadway Ada, Oklahoma, and must be delivered no later than Monday, September 9, 2024, by 5:00 p.m. CST.
- 3. Images must be submitted in jpg. format with original metadata (data recorded by the camera at the time of capture) intact.
- 4. The file naming format is last name_first name_01.jpg and last name_first name_02.jpg (example: Wallace James 01.jpg).
- 5. Images cannot exceed 8"x10", or 3000x2400 pixels, with a resolution of 300 dpi.
- 6. Data from the image file will be used to validate the images' authenticity.
- 7. Images will be checked to ensure the origination date is within the contest time frame.
- 8. Because the date cannot be confirmed, copy negatives are not permitted.
- 9. Images should not bear watermarks, date stamps or other identifying marks.
- 10. The identity of the photographer will not be displayed for the judges during scoring.
- 11. Editing is limited to the following:
 - a. For COLOR images, photographers may use the Adobe Camera Raw plug-in or assorted Photoshop techniques to accomplish the following tasks:
 - i. Adjust exposure.
 - ii. Adjust tone.
 - iii. Adjust the white balance.
 - iv. Globally adjust color.

- v. Dodge (at brush sizes no smaller than 20px).
- vi. Burn (at brush sizes no smaller than 40px).
- b. Photographers may **not**:
 - i. Clone.
 - ii. Heal.
 - iii. Paint.
 - iv. Composite.
 - v. Sharpen.
 - vi. Use any feature not listed above.
- c. For BLACK-AND-WHITE images, the process of emulating black-and-white photography using digital techniques requires the use of a wider set of tools. In addition to those tools listed above, the following may be used:
 - i. Channel mixer.
 - ii. Black-and-white adjustment in Photoshop or the Adobe Camera Raw plug-in.
 - iii. Multi-burning.
 - iv. Color toning (sepia, copper, etc.).
- 12. Images not meeting the technical specifications will be disqualified.
- 13. Disqualified images will not be displayed.
- 14. A photographer who submits an image that is disqualified will be notified by email and given 48 hours to offer an appeal to defend the image if they feel they have been incorrectly disqualified.

Submission guidelines:

- 1. Each photographer can submit no more than two photos.
- 2. Because we welcome photographers of all ages, all images must be family-appropriate to be accepted.
- 3. Refrain from any subject matter that is violent or suggestive, any work exhibiting this will be rejected.
- 4. Refrain from any subject matter that is discriminatory, racist or bigoted, any work exhibiting this will be rejected.
- 5. The application of the themes should be creative, but not contrived.
- 6. Photographs that incorporate other artwork, whether photographic or traditional, must incorporate that artwork into a larger photographic scene. Photographs of non-photographic artwork alone do not meet the requirements to be considered original photographs for this competition.
- 7. Images that merely contain the written text of the theme will be rejected.

<u>Judging</u>:

Judges will score on the following categories:

- 1. Exposure, contrast and color:
 - a. Images should be properly exposed and contain sufficient contrast.
 - b. All pertinent details should be visible.
 - c. Is the photograph exposed in a way that works for the image?
 - d. Does the lighting show off the subject well?
 - e. Is the contrast level appropriate?
- 2. Focus and depth of field:
 - a. Images should be in focus.
 - b. If an image is out of focus, it must be done with intent and it should be clear that it was not merely a mistake.
 - c. The depth of field is the thickness of the area that is in focus.
 - d. The correct depth of field for an image can be somewhat variable and images will be judged on how well the choice of depth of field serves the image.
 - e. Is the focus appropriate for the subject?

- f. Is the depth of field appropriate?
- g. Is depth used (or not used) to good advantage?
- 3. Framing and composition:
 - a. Images should be well cropped.
 - b. Images should demonstrate good composition.
 - c. Symmetry, asymmetry, placement of elements and the effective use of foreground and background elements may be considered.
 - d. Is the composition skillful and dynamic?
 - e. Is the image balanced or unbalanced?
 - f. Is the balance level appropriate?
 - g. Are there distracting elements in the picture that could be eliminated?
 - h. Are there too many unrelated elements or too few elements?
 - i. Does the framing work?
- 4. Artistry, originality and appeal:
 - a. Images are judged on overall artistic merit and originality.
 - b. Does the subject have interesting connotations or associations?
 - c. Does the image show an original subject or an original approach to a standard subject?
 - d. Is it anonymous or does it show a visual signature or convey a personal vision?
- 5. Execution of the theme:
 - a. How well does the photograph capture or illustrate the theme?
 - b. Does the image effectively tell a story about the theme or convey a mood or value?

Winners will be announced Friday, October 25, 2024, at the awards reception to be hosted at 6:00 p.m. CST in the Chokma'si Gallery, 201 North Broadway, Ada, Oklahoma.

The photographer will comply with all Chickasaw Nation COVID-19 policies, procedures and guidelines, as may be amended from time to time, while on Chickasaw Nation property. If in the days before the event, the U.S. weekly growth rate of COVID-19 cases averages 7% or more, the Chickasaw Nation may immediately cancel the in-person exhibit. Current guidelines in place at the time of the event will be communicated to the photographer seven days in advance of the event.
