## Home Improvement Grant Information Sheet

The home improvement grant can be used to make improvements to your home. Some improvements may require a licensed professional such as electrical, plumbing, gas and heating/air. Previously improved items need prior approval. You may contact a contractor in your area and have the business provide an estimate for your improvement. Each contractor's estimate must list the contractor's name, address and phone number. The estimate needs to include where the repairs are being done (your name and address). Improvement estimates must be itemized, for instance, materials and labor. Once approved, a check will be issued, made payable to you and the contractor. Reimbursement cannot be made for any improvement completed prior to our notification to you of grant availability.

Once your application is approved, your estimate can be mailed to P.O. Box 788, Ada, OK 74820, sent by fax to (580) 559-0720 or emailed to <u>AdmissionsDept@Chickasaw.net</u>. The estimate for improvements must be received within 30 days of the date of this letter.

Examples of eligible items for home improvement grants include the following:

- 1. Roofing repair (non-insured damage)
- 2. Repair/replace hot water tanks
- 3. Repair/replace air conditioners and heating units
- 4. Siding/exterior repair
- 5. Flooring/carpet
- 6. Foundation issues
- 7. Repair/replace windows/doors
- 8. Lighting
- 9. Painting
- 10. Repair/replace cabinets and/or countertops
- 11. Kitchen remodel

- 12. Electrical repair
- 13. Bath remodel
- 14. Plumbing/gas repair
- 15. Repair/replace water wells/pumps/water lines
- 16. Handicap accessibility items
- 17. Piers (needed to correct structional damage)
- 18. Sewage problems (including lateral lines)
- 19. Gravel to enable access to the residence

Examples of ineligible items for home improvement grants include, but are not limited to, the following:

- 1. Fencing/gates
- 2. Add-ons
- 3. Security systems
- 4. Storage buildings/barns
- 5. Landscaping
- 6. Swimming pools/spas/hot tubs
- 7. Gazebos/pergolas
- 8. Reimbursement of any kind
