CHICKASAW NATION LIFETIME HUNTING AND FISHING LICENSE

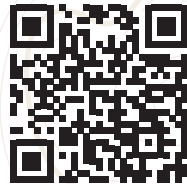
Chickasaw citizens can apply for a lifetime license to hunt and fish within the Chickasaw Nation. An Oklahoma state hunting and fishing license is not required to participate in this program.

Chickasaw citizens can submit an application at no cost. Additional eligibility requirements may apply.

LICENSEE PERMIT-TRIBAL LAND SPECIAL HUNT

Whitetail deer and turkey hunts on Chickasaw Nation-owned lands are available through a special draw. From the Kullihoma Hunting Grounds to other sections of land across the Chickasaw Nation, this special draw program offers hunters a chance to hunt on over 3,400 acres of prime hunting land. FAQS

What is the Five Tribes Wildlife Management Reciprocity Agreement?

In July 2024, the Cherokee Nation, Chickasaw Nation, Choctaw Nation of Oklahoma, Muscogee (Creek) Nation and Seminole Nation of Oklahoma each signed an agreement to honor each other's hunting and fishing licenses. Citizens and members can utilize their license to enjoy hunting and fishing within participating tribes' treaty territories. However, hunters and fishers must still follow the specific rules of the tribe where they are hunting or fishing and adhere to federal laws. Citizens must receive permission before hunting on private land or in Wildlife Management Areas.

Who is eligible to hunt and fish within the Chickasaw Nation?

Chickasaw citizens, other participating Five Tribe members and individuals with a valid state-issued license can hunt and fish within the Chickasaw Nation.

What does a Chickasaw citizen need to carry to show they are licensed by the Chickasaw Nation?

Chickasaw citizens must carry their valid, tribally issued hunting and fishing license. Law enforcement are also authorized to accept a valid Oklahoma Department of Wildlife Conservation license if you have not yet received your Chickasaw Nation license. If you receive conflicting guidance from officials while in the field, please address the situation respectfully. Contact the Chickasaw Nation Rangers to report the incident and provide details on what occurred. You can apply for a license at Chickasaw.net/Hunting.

Are Chickasaw Nation Hunting and Fishing License holders required to purchase deer and turkey tags? How does a Chickasaw citizen check-in a harvest?

Prepurchased tags are not required; however, field-tagging and check-ins are required. The Chickasaw Nation Fish & Wildlife Service provides an online portal for Chickasaw citizens to report the harvest of any species with a check-in requirement. Harvests are required to be reported within 24 hours to obtain a unique confirmation. More details are available at Chickasaw.net/Hunting.

What is the annual bag limit for deer within the Chickasaw Nation?

The limit is six deer per year, with no more than two being antlered, and no person may claim multiple bag limits. Deer taken during special draw hunts or the holiday antlerless deer gun season do not count toward this limit. The bag limits established under Chickasaw Nation law are consistent with the limits that apply under Oklahoma law and the laws of the other tribes that are party to the Five Tribes Wildlife Management Reciprocity Agreement. These limits are meant to be cumulative and are not stackable. In the interest of sustainable wildlife management, absolutely no "double dipping" will be allowed.

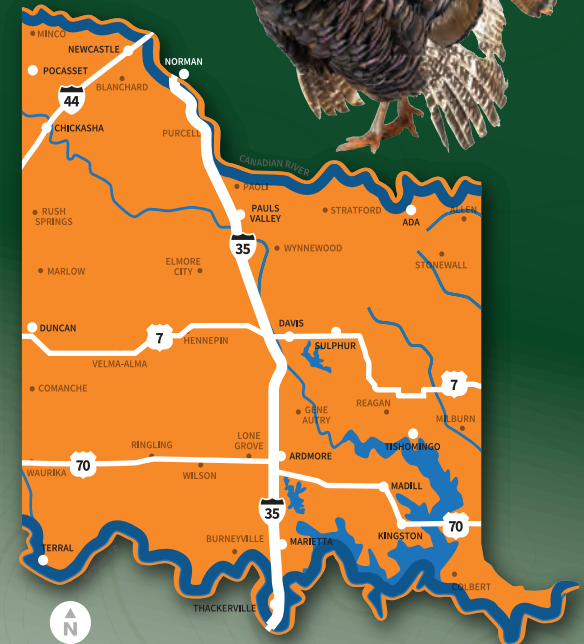
